### **Terms of Use and Privacy Policy**

Smart Prism Fincap Pvt Ltd along with its Affiliates/ Group companies (SPFPL) recognizes the importance of maintaining your privacy. SPFPL is committed to maintain the confidentiality, integrity and security of all information of its users. SPFPL collects and handles certain information it may collect and/or receive from you via the use of this Website or otherwise. By visiting and/or using our website, you are accepting and consenting to the practices described in this Privacy Policy.

By using or continuing to use the Website you agree to our use of your information (including sensitive personal information as defined under the Information Technology Act, applicable rules, notification etc.), as may be amended from time to time by the Website in its discretion.

# **Purpose of gathering Personal Information**

The information we take from customers helps us personalize and continually improve your experience on the Website/App. Here are the types of information we gather.

We receive and store any information you enter on our App/Website or give us in any other way. You can choose not to provide certain information but then you might not be able to take advantage of many of our services and features.

We receive and store certain types of information whenever you interact with us. - Send you notices, communications, and recommend services that might be of interest to you, update our records and generally maintain your accounts with us, display content and customer reviews.
- As otherwise provided in this Privacy Policy.

#### **Use of Personal Information**

SPFPL collects your information when you register for an account, when you use its products or services or visit its Website's page(s). When you register with SPFPL, you are asked for your Full Name, Email address and Mobile Number. Once you register at the Website/App and sign in you are not anonymous

to us. Also, you are asked for your contact number during registration and may be sent SMS, notifications about our services to your wireless device. Hence, by registering you authorize SPFPL (including its business partners and affiliates) to send texts and email alerts to you with your login details and any other service requirements, including promotional mails and SMS, even if you have registered yourself under DND or DNC or NCPR services. Your authorization shall be valid as long as your account is not deactivated.

Some features of this Website or our Services will require you to furnish your personally identifiable information as provided by you under your account section on our Website.

You also agree and consent to us for collecting, storing, processing, transferring and sharing information (including sensitive personal information) related to you with third parties or service providers for the purposes as set out in this Privacy Policy.

#### **Information Sharing:**

SPFPL will not sell or rent or otherwise disclose your information for commercial purposes to anyone in a way that is contrary to the commitments made and/or other than as set forth in this Privacy Policy. Notwithstanding the foregoing, we may share your information to an affiliate and/or business partner. SPFPL may also share, sell, and/or transfer your personally identifiable information to any successor-in-interest as a result of a sale of any part of SPFPL business or upon the merger, reorganization, or consolidation of it with another entity on a basis that it is not the surviving entity. For the purposes of this paragraph, "affiliate" means any person, company, or SPFPL directly, or indirectly through one or more intermediaries, that controls, is controlled by or is under common control with SPFPL (The term "control," as used in the preceding sentence, shall mean with respect to any person, the possession, directly or indirectly, of the power, through the exercise of voting rights, contractual rights or otherwise, to direct or cause the direction of the management or policies of the controlled person. As used in this Privacy Policy, the term "Person" includes any natural person, corporation, partnership, limited liability company, trust, unincorporated association, or any other entity).

We limit the collection and use of your personal information. We may make anonymous or aggregate personal information and disclose such data only in a non-personally identifiable manner. Such information does not identify you individually. Access to your Account information and any other personally identifiable information is strictly restricted and used only in accordance with specific internal procedures, and for the purposes set out in this Privacy Policy, in order to operate, develop or improve our services. We may use third party service providers to enable providing you with our services and we require such third parties to maintain the confidentiality of the information we provide to them, under our contracts with them.

We may also share your information, without obtaining your prior written consent, with government agencies mandated under the law to obtain information for the purpose of verification of identity, or for prevention, detection, investigation including cyber incidents, prosecution, and punishment of offences, or where disclosure is necessary for compliance of a legal obligation. You agree and consent for the Website to disclose your information, if so required, under applicable law.

There are a variety of products/services such as loans and credit cards offered by third Parties on the Website, such as lenders, banks, credit card issuers. If you choose to apply for these separate products or services, disclose information to these providers, then their use of your information is governed by their privacy policies in addition to the Privacy Policy of the Website. SPFPL is not responsible for their privacy policies. SPFPL understands that the confidentiality, integrity, and availability of your information are vital to our business operations and our own success. Further, you are responsible for maintaining the confidentiality and security of your login id and password, and may not provide these credentials to any third party.

#### **Your Control Over Your Personal Information:**

It's important to note that the information we use about you helps us provide you with products, services and experiences that benefit you. You have the ability to control how your non-personal information is collected and used online.

You also have the ability to choose what personal information, including what sensitive personal information (i.e., your financial information) you provide to us.
